The Coalition for the Cleveland City Browns (CCCB) is a nonprofit civic advocacy organization. We value transparency and are committed to responsibly handling the information you share with us. This Privacy Policy explains how we collect, use, and disclose information through our website and related services.

1. Information We Collect

When you interact with our website, we may collect:

- **Personal Information:** Name, email address, phone number, billing details, and mailing address (e.g., when you donate, sign a petition, or join our mailing list).
- **Payment Information:** Donations and payments are processed through third-party providers (e.g., Wix Payments, PayPal, Stripe). CCCB does not store your full credit card or banking information.
- **Technical Information:** IP address, browser type, device information, and website usage data (collected automatically via cookies or analytics tools).
- **Communications:** Messages, comments, or submissions through forms on this site.

2. How We Use Your Information

We use information collected to:

- Process donations and issue receipts.
- Communicate with you about CCCB events, advocacy efforts, and updates.
- Maintain accurate supporter records.
- Improve our website and online services.
- Comply with applicable laws and regulations.

3. Disclosure of Information

- CCCB may disclose information to proper authorities or government agencies when legally required or requested.
- We may share information with trusted service providers (e.g., donation platforms, payment processors, email providers) who help us operate our nonprofit.
- We do **not** sell your personal information to third parties.

4. Cookies and Tracking

- Our website uses **cookies and similar technologies** to improve functionality, personalize your experience, and analyze site usage.
- Cookies may also be used by third-party services (e.g., Google Analytics, Wix apps).
- You may disable cookies in your browser settings, though some features of the site may not function properly.

5. Data Security

- We implement reasonable safeguards (technical, administrative, and physical) to protect personal information.
- However, no method of online transmission or storage is 100% secure. By using this site, you acknowledge that CCCB cannot guarantee absolute security.

6. Children's Privacy

- Our website is not directed toward children under the age of 13.
- We do not knowingly collect personal information from children under 13.
- If we become aware that we have collected such information, we will delete it promptly.

7. Retention of Information

- We retain personal information only as long as necessary for the purposes described in this policy, unless a longer retention period is required by law.

8. Your Rights

Depending on your jurisdiction, you may have the right to:

- Access, update, or correct your personal information.
- Request deletion of your personal information (subject to legal and operational requirements).
- Opt out of email communications by clicking "unsubscribe" in our emails.
